**RESOLVED** that due to the libelous and personal nature of the email received aimed at the Assistant Town Clerk together with the threatening manner towards the Town Council, the decision made at the meeting of the Events & Communications Committee, Minute no. 134313, item a) (i) & (ii) held on Wednesday 4<sup>th</sup> October 2023 is hereby rescinded.

**RESOLVED** that because of this unacceptable email correspondence with unsubstantiated and baseless allegations aimed at the Assistant Town Clerk and the Town Council, together with the late proposal handed to the Chairman at the Events & Communication meeting held on 4<sup>th</sup> October 2023 with unacceptable demands, Hessle Town Council considers Mr Tuby unsuitable to work or associate with and therefore declines his demands and do not wish him to attend the Hessle Town Council 2023 Christmas Lights Switch-On event or any further Hessle Town Council organised events. A letter will be sent to Mr Tuby advising him of the Town Councils final decision with a copy forwarded to the Showman's Guild.
